



Exhibitor Personnel Registration Form 20' x 30' Booth Space

Each company is entitled to eighteen (18) complimentary badges and six (6) guest badges for each 20' x 30' booth space purchased. Complimentary badges permit exhibitor personnel entry into Exhibit Hall, receptions, and sessions on a space available basis. A guest badge permits entry into Exhibit Hall only (not educational sessions or events) for a guest and is not to be used for exhibitor personnel. Guest badges are picked up onsite only. There is no pre-registration for guest badges. The guest can retain the badge as long as you want. These badges are not named badges and will include only your company name. Your guests pick them up and drop them off as needed at the exhibitor registration counter, or you can control the guest badge. If you need more than 6 guest badges, you can purchase a one-day exhibit hall pass or they can register for the entire meeting.

Additional badges may be purchased for exhibitor personnel at \$50.00 each for up to 20 registrants per company. If you are purchasing 21 or more exhibitor badges, the cost is \$100 per registrant. Exhibitor representatives are restricted to personnel engaged in the installation/dismantling, demonstration, application or sale of the company's product and/or services. All other employees of exhibiting companies must register as meeting attendees.

The official SIIM 2008 badge must be worn in the Exhibit Hall at all times. Installation and dismantling personnel must wear special I&D badges while in the hall. They may be obtained at the Exhibitor Registration counter. Each individual exhibitor and/or exhibit representative will be responsible for procuring his/her own badge at the Exhibitor Registration counter. Badges will not be distributed in bulk to one company representative. Onsite badges will only be issued to individuals presenting a company business card or letterhead, or with an official company representative present.
